

2018 Year 5/6 Camp at Mill Valley Ranch



In 2018, we will run our Year 5/6 Camp early in Term 1 to provide an opportunity for teachers and students to develop strong relationships. We also believe that having a camp in Term 1 will have the additional benefit of having warmer weather and less chance of rain.

Camp dates: Monday 19th February to Wednesday 21st February.

We are excited about the opportunity for students to engage in horse riding in addition to their usual camping activities.

We are aware that organising a camp so early in the year will have some challenges. It will be important that all paperwork and payments are returned promptly. Unfortunately, delays in returning these may result in a student missing out on this opportunity. To assist with this, we are providing early notice about the camp and parents are welcome to start payment plans immediately. Any money paid, will be held in the school account under your child's name and allocated to the camp. As always, if you are having financial difficulties but would like your child to participate in camp, please contact Debbie Dodd to discuss options for support.

Families eligible for CSEF in 2018 will be able to allocate this payment of \$125 towards the cost of camp. It cannot be used as the deposit this year.

The camp will cost \$225 per student and we will require an expression of interest and a deposit of \$100, or the development of a payment plan by the 1st December 2017 (please remember, earlier is better). The final payment will be required by Monday 5th February 2018. Please do not wait until the last minute to ask for assistance or to ask if you can develop a payment plan as this can cause stress and can unfortunately result in the camp being full and your child missing out.

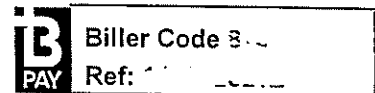
